<b>01</b>	Visa application Form duly completed and signed personally by the applicant																		
<b>02</b>	01 Photo of recent identity in color on <b>white background</b> .																		
<b>03</b>	<b>Original passport</b> valid for at least 3 months after the expiration of the requested visa and Photocopy of the entire latter. The passport must have at least three free pages and has been issued for less than ten years.																		
<b>04</b>	<b>Travel insurance</b> of a duration equal to that of the visa requested Valid for all the countries of the Schengen area, Covering medical and repatriation costs in the event of an accident or illness ( Minimum coverage: €30,000).																		
<b>05</b>	<b>Proof of the purpose of the trip:</b> <ul style="list-style-type: none"> <li>▪ Confirmation of hosting by the inviting company, or</li> <li>▪ Hotel Reservation, or</li> <li>▪ Certificate of private accommodation mentioning the assumption of costs by the host, or</li> <li>▪ Proof of rental or ownership of real estate, or</li> <li>▪ Proof of sufficient means to cover accommodation costs.</li> </ul>
